Changes have been made to the Inspection Grade Cards that are issued at the end of a routine inspection to make it more visually appealing and functional for both consumers and businesses.

Businesses will now need to post only one grade card and consumers will be able to more easily contact Public Health with any complaints/concerns.

Older grade cards and notification cards will remain valid until replaced. We anticipate the rollout will continue through this year.
